**1. INTRODUCTION**

1.1. National Institute of Technology Warangal is an Institution of National Importance functioning under the aegis of the Ministry of Education, Government of India, governed by the National Institutes of Technology, Science Education and Research (NITSER) Act, 2007. The Institute invites online applications for filling faculty positions at various levels - Assistant Professor Grade II, Assistant Professor Grade I, Associate Professor and Professor.

- 1.3. Indian citizens and Overseas Citizen of India (OCI) Card holders fulfilling the eligibility criteria and possessing an excellent academic record, aptitude, commitment to quality teaching and research, and propensity towards institutional development are encouraged to apply.

## 2. IMPORTANT NOTES

- 2.1. The date for deciding the eligibility shall be the last date of submission of the application.
- 2.2. **In the Departments of Metallurgical & Materials Engineering, Chemistry and Physics, there are No Vacancies. Therefore, no applications are solicited. However, the candidates who are serving in NIT Warangal may apply.**
- 2.3. Reservation is applicable as per the Government of India norms. The candidates belonging to SC/ST/OBC-NCL/EWS/PwD are required to submit the category/caste Certificate in the format prescribed by the Government of India.

- 2.4. Candidates claiming reservation for OBC-NCL shall obtain the certificate from the Competent Authority in the format prescribed by the Government of India, and the Caste/Community should have been included in the Central list of Other Backward Castes. The crucial date for determining the OBC-NCL certificate shall be the last date of submission of the application.
- 2.5. Candidates claiming reservation under EWS are required to produce an Income and Asset certificate in the format prescribed by the Government of India, valid for the year 2025.
- 2.6. In case the vacancies reserved for EWS are not filled up due to non-availability of suitable/eligible candidate(s) belonging to the EWS category, such vacancies shall be treated as unreserved.
- 2.7. As an Institute of National Importance, NIT Warangal strives to have a workforce, which reflects an all-India character and the candidates from across the country, and also from abroad, are encouraged to apply.
- 2.8. NIT Warangal strives to have a workforce which reflects gender balance and equity, and hence female candidates are encouraged to apply.
- 2.9. As all the faculty positions are to be filled up by way of Direct Recruitment, the in-service faculty members of NIT Warangal aspiring for higher posts/ Pay Levels should also apply through the online portal, subject to fulfilment of the eligibility criteria, irrespective of the specialization requirements, as they are already serving in the Institute.
- 2.10. In terms of Note 1 (5) under Schedule 'E' of the First Statutes of NITs, for the departments which are not having any vacancy, movement in higher Academic Grade Pay or cadre shall be carried out as per the specified selection process, but it will be restricted only to serving faculty members of the respective departments.
- 2.11. The appointment of the selected applicant will be subject to being found medically fit as per the requirements of the Institute.
- 2.12. The Institute reserves the right to revise or modify at any time any conditions of the advertisement by issuing a suitable amendment or corrigendum, as it may deem fit. Such a corrigendum/addendum pertaining to this advertisement shall be published only on the Institute's website.

## 2 ELIGIBILITY CRITERIA

### 3.1 Essential Qualifications and Specializations

The Essential Academic Qualification for all the levels (Professor, Associate Professor, and Assistant Professor) is a Ph.D. in the respective discipline and shall have a First Class in the preceding Degrees. Candidates having a Ph.D. degree directly after BE/B.Tech are also eligible, and they should have obtained First Class at the Bachelor's level.

3.3 The clarifications issued by the Ministry on the Recruitment Rules vide letter bearing F. No. 33-9/2011-TS.III dated 16.04.2019 may be accessed from

3.4 Upper age limit for candidates applying for Assistant Professor Grade II with Pay level 10 is 35 years, Assistant Professor Grade I is 40 years, Associate Professor is 45 years, and Professor is 50 years. However, in the exceptional cases, the candidates with a high value of sponsored R&D grants/publication record / Ph.D. guidance, age can be relaxed, but not

exceeding 60 years for the fresh recruits. Age relaxation, as per the Government of India orders, will be applicable.

- 3.5 The cumulative essential credit point requirement is the minimum eligibility for scrutiny. Mere satisfying the criteria does not ensure final shortlisting/ appointment.
- 3.6 Most leading educational Institutions of the world have an explicit or implicit policy of not inducting their own students into the faculty. To avoid such inbreeding, the Institute will follow the following policies:
  - 3.6.1 Candidates who have acquired a Ph.D. degree from NIT Warangal can apply only after having at least 3 years of post-Ph.D. experience. This does not apply to candidates who are already members of the faculty, either regular or on contract at NIT Warangal.
  - 3.6.2 In special cases, where the department (at the time of shortlisting) or the Selection Committee feels that an exception needs to be made (for reasons such as severe shortage of faculty in a given academic field or exceptionally brilliant candidate or any other), the reasons for such exceptions are to be recorded in writing and put up to the Board of Governors for approval. The Board, if convinced, may confirm the selection. Such appointments will not serve as a precedent.

#### **4 SELECTION PROCESS**

All online applications received till the last date of submission of the application will be taken into consideration for the selection process comprising of scrutiny, shortlisting (higher criteria than the cumulative essential credit points / written test). Further shortlisting may be adopted through presentation of a teaching & research seminar. Shortlisted candidates will be invited for a personal interview before the duly constituted selection committee.

#### **5 PAY, ALLOWANCES AND INCENTIVES**

The faculty members of the Institute shall be entitled to avail:

- 5.1 Dearness Allowance, Transport Allowance and such other allowances as are applicable to the Central Government Employees. NIT Warangal is a residential campus. Suitable residential accommodation as per norms will be provided, subject to availability. In case of non-availability of campus accommodation, House Rent Allowance may be provided.
- 5.2 Reimbursement of Children Education Allowance as per Central Government Rules.
- 5.3 Reimbursement of Medical expenses, including referral to outside specialized and reputed hospitals at Warangal and Hyderabad for cashless treatment for self and dependent family members.
- 5.4 Leave Travel Concession (LTC) as admissible to Central Government Employees.
- 5.5 National Pension Scheme for all direct recruits, except those incumbents who are governed by CCS (Pension) Rules as on the date of appointment in the Institute.
- 5.6 Cumulative Professional Development Allowance (CPDA) as per Institute norms from time to time for presenting papers or chairing sessions in national/ international conferences, membership of professional societies, and purchase of books, amounting to Rs. 3 lakh.
- 5.7 An initial research seed grant of Rs. 5 lakh to the newly recruited faculty members may be provided.

## **6 GENERAL INFORMATION / TERMS**

- 6.1 NIT Warangal has adopted the four-tier flexible faculty structure. Any new guidelines and/or clarifications issued by the Ministry of Education, Government of India, shall be applicable at any stage of the recruitment process.
- 6.2 All the qualifications acquired by the applicant should be from an Institute/ University recognized by the University Grants Commission/ AICTE/ Government of India.
- 6.3 The Institute reserves the right to prescribe shortlisting criteria higher than the minimum criteria notified for different positions to arrive at a reasonable number of candidates to be called for presentation and/ or interview.
- 6.4 The Institute may shortlist the candidates depending upon the requirement of manpower in the particular specialization of different departments in addition to other criteria.
- 6.5 Before applying, the candidate should ensure that he/ she fulfill all the eligibility criteria. Candidates should ensure that they fill in the correct information. The candidate would be admitted to various stages of the recruitment process based on the information furnished by the candidate in his/her application. The candidature of the applicants shall remain provisional till detailed scrutiny is undertaken. NIT Warangal would be at liberty to reject any application at any stage of the recruitment process if the candidate is found ineligible for the post or if it comes to its notice at any stage. The decision of NIT Warangal with regard to the eligibility of the candidate shall be final. The mere fact that a call letter has been issued to the candidate and allowed to appear in the presentation and/ or interview or offered the post or allowed to join, will not imply that his/ her candidature has been finally cleared or that entries made by the candidate in his/ her application have been accepted as true and correct.
- 6.6 Candidates are cautioned not to furnish any incomplete, false or misleading information or submit any document which is defective, forged or fabricated or otherwise not admissible to claim fraudulently SC/ST/OBC/EWS/PwD status, etc. Incomplete applications will summarily be rejected. Notwithstanding verification of original documents during various stages of selection process, if any case of illegality is detected at any stage of the selection process, or later on, the Institute reserves the right to cancel candidature or selection, apart from taking appropriate legal actions.
- 6.7 Since many departments/subjects/specializations exist and are not comparable with each other, following a uniform standard/norm for shortlisting of candidates by a department is not feasible. Hence, departments may fix different criteria for different positions/Pay Levels and also for different specializations if required during scrutiny.
- 6.8 Candidates shortlisted for interview will have to produce original documents for verification in support of their application regarding reservation category, educational qualification, experience and other claims.
- 6.9 It is mandatory to have a personal appearance in the interview for applicants who are residing in India. However, candidates located outside the country and otherwise not in a position to attend the personal interview in exceptional circumstances may be interviewed through virtual mode at the discretion of the Selection Committee.
- 6.10 III-Tier AC will be paid for attending the interview, as per rules.
- 6.11 Apart from merit, the specialization of an applicant will be taken into consideration for short-listing as required for hiring faculty for a department.

- 6.12 A candidate found to be suitable for a lower post (or Pay Level) than the post he/she had applied, may be offered the lower post based on the recommendation of the Selection Committee. Similarly, subject to Act and Statutes, experienced and/or meritorious candidates may be offered higher starting pay on the recommendation of the Selection Committee.
- 6.13 Information regarding application status, interview schedule, etc., will be made available in the Institute's recruitment portal only. The Institute will not be responsible in any manner if a candidate fails to visit/access the portal in time. Candidates are advised to regularly visit and login to the Institute's recruitment portal for update status/ information once their application status is under scrutiny. Application IDs of the provisionally shortlisted candidates only will be displayed on the Institute website.
- 6.14 The Institute reserves the right to call shortlisted candidates for presentation and/or interview. The Institute reserves the right to defer or cancel the selection process at any stage without assigning any reason thereof. The Institute also reserves the right to consider and to fill or not to fill any positions in any of the specialization(s) / department(s) / centre(s).
- 6.15 The decision of the Institute in all matters will be final and binding on all the applicants who responded to this advertisement. No interim correspondence or unsolicited query will be entertained from the candidates in connection with the process of scrutiny/selection, including reasons for not being shortlisted for a personal interview.
- 6.16 In case of any inadvertent mistake in the process of selection, which is detected at any stage, even after the issue of appointment order, the Institute reserves the right to modify/withdraw/cancel any communication (including the offer of appointment) made to the candidate.
- 6.17 Any legal dispute arising out of this advertisement is subject to the Courts having jurisdiction over Warangal, Telangana.
- 6.18 Canvassing in any manner or an unsolicited query would entail the disqualification of a candidate.
- 6.19 Persons already employed in Government / Public Sector Enterprise / Autonomous Bodies should forward a copy of their application through the proper channel or should furnish a **No Objection certificate (NOC)** from the competent authority at the time of presentation/ interview.
- 6.20 Information uploaded on the website shall not be provided to the candidate or any other person under the RTI Act 2005. During the ongoing process of recruitment, neither any application under the RTI Act shall be entertained, nor information will be provided. Factual information under the RTI Act 2005 shall be provided only after declaration of the final results of the process. Inferential questions or speculative questions shall not be answered in RTI.

## **7 PROCEDURE FOR SUBMISSION OF APPLICATIONS**

- 7.1 Applications and the supporting documents will be accepted online only. Any applications (and the supporting documents) received by way of other means, such as post/ e-mail, etc., will be summarily rejected and will not be considered under any circumstances.
- 7.2 Candidates interested in applying for one or more posts may apply through the online recruitment portal available at <https://recruit.nitw.ac.in/> by paying a non-refundable application fee as given below, for each post applied for:

An online application can be filled out in multiple sessions. The applicants who have applied against the previous notification (ref No.: F. No. NITW/FR/2024, dated 22<sup>nd</sup> December 2024) and could not be considered due to non-availability of a vacancy, may submit application for the same post (and category) without application fee. However, a fresh online application is to be submitted if applying for a different position.

- 7.3 Separate applications must be submitted if an applicant is applying for more than one faculty position.
- 7.4 Candidates are required to upload all documentary evidence in support of their credentials and claimed credit points.
- 7.5 Candidates are advised to upload their research and teaching statements.
  - 7.5.1 Research Statement for NIT Warangal: We welcome research initiatives and efforts of all natures. Research statement will be evaluated on clarity of thought, seriousness and contextualizing with respect to efforts by the global research community wherever possible.
  - 7.5.2 Teaching Statement for NIT Warangal: Applicant must indicate core or elective courses he/she can teach or develop. If applicable, please include a short note on previous teaching experience and mention recognitions of excellence in teaching wherever received.
- 7.6 The PDF copies of the following documents/certificates are required to be uploaded on the Recruitment Portal while submitting the online application form. Incomplete applications owing to non-submission of crucial information, including, but not limited to, non-submission of the following documents, will be summarily rejected.
  - 7.6.1 Age Proof: Matriculation/ 10<sup>th</sup> Standard/ Secondary or equivalent certificate indicating the date of birth, issued by the Central/ State Board indicating the date of birth. Where the date of birth is not available in the certificate/ marksheets issued by the concerned educational boards, a School Leaving Certificate indicating the date of birth may be considered.
  - 7.6.2 Higher Secondary/ Class XII (or equivalent) board marksheet.
  - 7.6.3 Preceding Degrees: Degree certificates of UG and PG, along with marksheets pertaining to all academic years as proof of educational qualification(s) claimed.
  - 7.6.4 Essential qualification: Ph.D. degree or Provisional Certificate or Notification of Ph.D. award issued by the authorized signatory (not the Mentor/ Supervisor/ Head of the Department)
  - 7.6.5 Category Certificate: Candidates belonging to reserved categories shall submit the latest category certificate in the format prescribed by the Government of India.

- 7.6.6 Disability/ Medical certificate issued by the competent medical authority, if applicable.
  - 7.6.7 Photo Identity Card issued by any Govt. agency/ last attended Institution/ University.
  - 7.6.8 Experience Certificate(s): Experience Certificate(s) from the Head(s) of Organization(s) for the entire experience claimed, clearly mentioning the duration of employment (date, month & year), indicating the Pay Level/ Grade Pay and Basic Pay. The certificate(s) should also cite the nature of duties performed/ experience gained in the post(s) with duration.
  - 7.6.9 Any other relevant documents in support of the entries in the application form.
