No post is reserved for SC/ST/OBC communities. The candidates having the required performance/ achievement in the particular sports discipline will be selected on the basis of overall merit irrespective of their communities. However, the candidates may upload the communities they belong to. This is strictly required vide chapter 13 of the brochure (published by Govt. of India/Ministry of Personnel, Public Grievance of Pensions Deptt. of Personnel Training, New Delhi.) The Caste certificate shall be issued by the Competent Authority, not below the rank of Tehsilder in case of SC/ST/OBC communities. OBC candidates shall also upload OBC Non-Creamy Layer certificate in the Central Govt. format issued not before than 01 year by the competent authority.

**3. ELIGIBILITY CRITERIA :**

**3.1. Age Limits** - Minimum 18 years and maximum 25 years as on **01.01.2026**. There is no age relaxation for SC/ST/OBC candidates. Copy of Matriculation or its equivalent certificate from a recognized Board, **OR** the Birth Certificate should be uploaded for proof of Date of Birth.

(Date of Birth not earlier than **02.01.2001** and not later than **01.01.2008**)

b) **In Athletics (Men)**, Gold Medal winner in Open National Championship (Senior), Inter State Athletics Championships (Senior) and Asian Championships (Senior) may be considered for recruitment in Pay Level 4/5 (As per 7th CPC).

c) **In Athletics (Men)** - Medal winning performance in National Inter State Senior Athletics Championship, may also be considered for recruitment in Pay Level 2/3 (As per 7th CPC).

d) **In Hockey (Men/Women)**, for recruitment against the posts having Grade Pay Rs. 1900/2000/- in Pay Band Rs. 5200- 20200/- participation in the International Tournament (Senior or Junior) of four or more nations may also be considered.

**In Hockey (Men/Women)**, Semifinalist in Senior National Championships may be considered for Grade Pay 1900/2000/- in Pay Band 5200-20200/-. Events recognized by the 'Hockey India' shall be considered for the purpose of recruitment in the discipline.

e) **In Chess (Men)**, Following Sports achievements may also be considered for recruitment in :-

g) **Rifle Shooting (Men)**:- National Shooting Championship Competition (for all age groups) - only individual performance shall be considered for recruitment purpose.

**IMPORTANT :**

1. The applicant must have earned the achievements mentioned above, on or after 01.04.2023.
2. The concluding day of the Championship/Event shall only be taken into consideration for this purpose.
3. All the Championships/Events mentioned above should have been conducted under the aegis of International / National Sports Federations/Association duly recognized by the Ministry of Youth Affairs & Sports (MoYAS) at the time of that Championship.
4. No recruitment shall be made on the basis of certificates issued for National Championships conducted by any federation that was not recognized by MoYAS at the time of that championship.
5. The updated list of recognized NSFs is published on the Ministry's website from time to time.

**3.3 Sports norms for Level-1**

a) **Represented the Country** in any of the Championships/events in the Commonwealth Championship (Junior/Senior Category)/Asian Championship/ Asia Cup (Junior/Senior Category)/South Asian Federations (SAF) Games (Senior Category)/ USIC (World Railways) Championship (Senior Category)/ World University Games.

b) **At least 3<sup>rd</sup> Position in Federation Cup Championships (Senior Category).**

**Or**

c) **Represented a State equivalent Unit**, excepted in Marathon and Cross Country with **at least 8<sup>th</sup> position in Senior National Championship**.

d) **In Cricket (Men)** :- In Cricket, at National Level, following Sports achievements in 4 days/One day limited Overs/Twenty-20 Cricket Championships (except Vizzy Trophy) organized under the aegis of BCCI, may also be considered for recruitment against the posts having level-1.

**g) In Golf (Men),** For recruitment against the posts having Grade Pay Rs. 1800 in Pay Band Rs.5,200-20,200: sportsperson having I.G.U. ranking upto 100; subject to single handicap i.e. less than 10 (in order of Merit/Amateur Merit list) shall also be eligible for recruitment. Only the current Annual All India Ranking shall be considered for these purposes.

The highest ranking in the year of recruitment may be considered for the purpose.

The players may be allowed to play in professional tournaments only after completing 5 years after their recruitment after taking NOC from RSPB.

**NB: The Sportspersons fulfilling the minimum Sports norms for recruitment in higher grades shall be eligible for recruitment in lower grades also. However such Sportspersons will be eligible for promotion/ re-appointment in higher grades only on the basis of his Sports achievement acquired after joining Railways.**

**3.5. Educational Qualification** - Candidates should possess requisite academic qualification while applying in response to the notification as given below. Those who are appearing at and/or awaiting results of final examinations are not eligible. Educational Qualification must be from a Recognized institution.

Note: i) No relaxation in minimum educational qualification shall be permissible.  
ii) Candidates must mandatorily submit photocopy of relevant documents in support of their educational qualification while filling up the application form and the original of educational qualification certificate must be produced on the day of Trials.

#### **4. HOW TO APPLY –**

i) Candidates should ensure that their Name/Spelling, Father's Name/Spelling, Community details, Educational Qualification and Date of Birth match with the entries recorded in Matriculation or equivalent certificate.

**In case there is significant deviation/difference in the Name/Spelling/Dates etc. in the documents of the candidate then his/her candidature will be cancelled from the day the discrepancy is noticed. No claim would be entertained in this regard. Hence candidates are advised to thoroughly check their documents.**

ii) Eligible candidates are required to go to the link provided for filling ONLINE application through website of RRC/SER ([www.rrcserser.co.in](http://www.rrcserser.co.in)) and fill up the personal details/BIO-DATA carefully.

iii) Candidates are advised to indicate their personal mobile no. and personal valid e-mail ID's in the ONLINE application and keep them active during the entire recruitment process for communicating with them.

#### **4.1 Examination Fees -**

(i) The Examination fee as detailed below to be paid :-

ii) Examination fee should be paid online through Internet Banking or Debit or Credit Cards (service charges for payment of fees will be borne by the candidates).

iii) Examination Fees in Cash/Cheque/Money Order/Central Recruitment Fee Stamps/ Demand Draft will not be accepted and accordingly application will be rejected.

iv) Candidates should confirm if they wish to receive the refundable portion of examination fees (Rs. 400/- or Rs.250/- as applicable) on attending Trials in the account from which they have made payment or alternatively, provide the beneficiary account in which they wish to receive the refund viz. beneficiary name, account number, name of Bank and its IFSC code. The refundable portion of examination fees shall be refunded duly deducting bank charges as applicable.

v) Rs.400/- to UR/OBC and Rs.250/- to SC/ST/ Ex. Servicemen/ Persons with Disabilities(PWDs), Women, Minorities and Economically Backward Classes will be refunded to those eligible candidates who will actually appear in the Trial.

#### **4.2 DOCUMENTS TO BE UPLOADED :-**

##### **PHOTOGRAPH :**

a) It should be a color passport-size photograph with white/light color background. It should be of size 3.5 cm X 3.5cm (not older than three months from the date of application). It should be in JPG/JPEG format scanned with 100 DPI resolutions. The size of the photograph should be up to 70 KB.

b) The photograph must match with the appearance of the candidate on the days of Trial and document verification and Medical test.

c) The photo should have clear front view of the candidate without cap and sunglasses.

d) In case the candidate wears glasses, then the photograph should not have any glare/reflections on glasses and eyes should be clearly visible.

e) Photos of the candidates on all documents should be identical in all stages of recruitment process. Candidates are advised to keep at least 06 (Six) copies of the same photograph for further use, as and when required during the recruitment process.

##### **SIGNATURE AND LTI :**

a) The applicant has to sign and put LTI on white paper with Black Ink within a box of size 50 mm x 20 mm or 140X60 pixels. The images should be in JPG/JPEG format scanned with 100 dpi resolution. Size of file should be between 10-40 KB.

b) The signature and LTI must be of the applicant only and not of any other person otherwise it would be treated as impersonation/fraud. Candidate should then upload scanned photograph, Left Thumb Impression and signature in following manner.

c) Signatures of the candidates on all documents should be identical in all stages of recruitment process. Signatures in different style at the time of Trial, Document Verification, Medical examination etc. may result in cancellation of candidature.

d) Signature should be either in Hindi or English and must not be in Capital or Disjointed letter.

**OTHER DOCUMENTS (In pdf format only ) :**

a) Self attested copy of a valid photo identity card issued by a government body/authority like Aadhar card/PAN card/Driving License/Voter ID Card. should be uploaded along with the application form. The candidate should carry this identity card in all stages of recruitment process along with the e-call letter so that the personal details viz. name/spelling, date of birth etc. mentioned in the online application are confirmed.

b) Self-attested certificate in proof of educational qualification issued by Board/Council/University as per para 3.5 should be uploaded along with the application form.

c) **Only Sports achievements certificates for the Championships concluded on or after 01.04.2023 to till date from recognized Sports Association of Indian University, must be uploaded.**

d) Self-attested certificate in proof of age (Matriculation/10th certificate) as per para 3.1.

e) Self-attested certificate in proof of all recognized Sports achievements as per para 3.2, 3.3 and 3.4.

f) Candidates claiming to be SC and ST communities - Self attested community certificates from the Competent Authority to uploaded along with the online application as per Annexure -I.

g) The OBC-NCL candidates - Self attested community certificate are required to upload from the Competent Authority with the online application as per Annexure-II. They should also submit self declaration as per Annexure-IIA indicating that the candidate does not belong to the Creamy layer. EBC Candidates: Candidates claiming to belong to EBC are required to upload self attested Income Certificate from the Competent Authority in the prescribed format Annexure - III of this Notification.

h) EWS candidates: - Self attested EWS certificate are required to upload from the Competent Authority with the online application as per Annexure – IV.

i) Minority Candidates:- Candidates claiming to belong to Minority Community are required to upload a declaration for waiver of Examination fees. (As per Annexure - V of this Notification).

j) EX –Servicemen – Discharge certificate & Pension related documents (copy of PPO).

k) Certificates in languages other than English or Hindi should be accompanied by an attested translation in English / Hindi.

**4.3. STEPS TO SUBMIT ONLINE APPLICATON:**

ii) Fill in the personal information viz. Name, Father’s name, Date of Birth, Community, E-mail address and Mobile number. On submission of required details an E-mail/SMS will be received in the registered E-mail ID/Mobile number. Open inbox of your registered E-mail/SMS and note the registration number and password.

iii) Login - using the Registration number & password sent in the E-mail/SMS.

a)	Follow the instructions and complete the registration process step-by-step

c)	Provide the details of a valid photo identity card and upload the same.
d)	Upload the scanned copy of Photograph, Signature and LTI, self attested certificates in proof of date of birth, essential education/technical qualifications and caste i.e. SC/ST/OBC/EBC/EWS, income certificate, self declarations pertaining to the OBC candidates and minority community candidates and Sports achievements.
e)	Make requisite payment using credit card/debit card or internet banking.
f)	During submission of ONLINE application, a Unique Registration Number will be generated and issued to each candidate. Candidates are advised to preserve/note their Registration number for further stages of recruitment process/ correspondence.
g)	No change whatsoever will be entertained after final submission of online application and hard copy should be the same as submitted online. Submit the properly filled up application form, take (02) two copies of print out of properly filled up application form.

h)	Candidates should have their own mobile number, valid & active personal email-id and should keep them active for the entire duration of recruitment as RRC shall send all recruitment related communication only through SMS and E-mail.
i)	RRC will not entertain any request for change of mobile and email address at any stage.


