### 2. Work Profile at IISc:

- Patient consultation and treatment
- Duties allotted as per roster (rotational shift/night duty)
- Roster duties include duties on gazette holidays and weekends.
- Taking care of emergencies (on-call basis)

### 3. Duration:

Engagement is purely temporary on a full-time contract basis, **initially for a period of one year and renewable annually up to a maximum duration of five years**, based on satisfactory performance. For candidates previously employed at IISc through appointments made by the HR Department, the duration of their prior service will be counted in the maximum permissible tenure of five years.

An annual increment of up to 10% is permissible in case of extension of contract, based on the performance and the recommendation of the CMO. Contract tenure will commence from the date of joining.
