All candidates applying for the above post should have a recognized MBBS degree, which is registered with Medical Council of India or by a State Medical Council.

UPPER AGE LIMIT

The upper age limit as on 01.03.2026 is 65 years, relaxable up to 70 years on approval of Competent Authority

TENURE

- The engagement is purely on Temporary basis for a period One Year. Subsequent renewal (s) will be for a period of maximum three years, subject to satisfactory performance and at the discretion of Management.
- There will be notice period of one (01) month, on either side, for discontinuing the part time engagement.
