Recruitment for the posts of Junior Resident (Non-Academic)

AIIMS Madurai is a healthcare Institute of National Importance, established by the Ministry of Health & Family Welfare, Government of India under the Pradhan Mantri Swasthya Suraksha Yojna (PMSSY). Applications are invited by the Executive Director, AIIMS Madurai for the post of **Junior Resident (Non-Academic)** on temporary basis for a period of 1 (one) year. The following post will be rolled over for walk in interview, if not filled.

1. UR - Unreserved, OBC - Other Backward Classes, SC - Scheduled Caste, ST - Scheduled Tribes.
2. 4% reservation for PwBD on horizontal basis applicable as per Government Rules.
3. Vacancies may increase or decrease at the time of selection. The number of vacancies indicated are provisional and are subject to change without any notice.

1) RESERVATION OF POSTS :

- i. The reservation for ST / SC / OBC / EWS / PwBD candidates is as per Central Govt. Rules.
- ii. **EWS / OBC / SC / ST Candidates** : Certificate should be issued by authorities prescribed by Govt. of India is to be enclosed.

2) Caste / Category Certificates:

A. OBC Category :

- i. The vacancies are being advertised in financial year **2025-26**, therefore, valid NCLOBC certificate issued during the period **from 01.04.2025 to 31.03.2026** will be considered valid.
- ii. Candidates applying under OBC category must produce the valid caste certificate in the format provided by the DoP&T vide O.M. No. 36036/2/2013-Estt. (Res.) dated 30.05.2014

and further clarification issued by DoP&T OM No. 36036/2/2013-Estt(Res-I) dated 31.03.2016.

- iii. **Certificate must be valid for employment in Central Government Institutions.** OBC candidate's eligibility will be based on Castes borne in the Central List of Govt. of India. **Their Sub-caste should also match with the entries in Central List of OBC, failing which their candidature as OBC candidate will not be considered.** The OBC certificate should clearly show that the applicant does not belong to the Creamy Layer.

B. EWS Category :

- i. The vacancies advertised under EWS Category are as per the instructions issued by DoPT, Ministry of Personnel, Public Grievances & Pension, Govt. of India, vide OM. No. 36039 / 1 / 2019-Estt (Res), dated 31.01.2019.
- ii. Application under **EWS category will be considered subject to submission of Income and Assets certificate on a prescribed format issued by the competent authority** and subject to verification of genuineness of the certificate by the issuing authority. As per DoP&T OM No. 36039/1/2019- Estt (Res), dated 31.01.2019, the crucial date for submitting income and asset certificate by the candidate is the closing date of application for the post, except in cases where date is fixed otherwise. **Candidates are required to upload valid EWS certificate based on income of Financial Year 2024-25 and must be valid for the year 2025-26.**

- C. Person with Benchmark Disability (PwBD)** are required to produce the Disability certificate (with degree of disability) in original issued by the Competent Authority (i.e. Medical Board duly constituted by the Central Govt. or State Govt.) at the time of interview. Candidates with disability of lower limbs between 50% to 70% shall be considered and in case candidates are not available of such disability in the category, then the candidates with disability of lower limbs between 40% - 50% can also be considered. The disability conditions falling under the category "likely to improve" "under temporary disability" category are not eligible for reservation. The condition i.e. "progressive, non-progressive or not likely to improve" are to be treated as eligible for reservation.

3) QUALIFICATION:

- ✓ The candidates should have passed MBBS (including completion of Internship) or equivalent degree recognized by MCI / NMC.
- ✓ Only those candidates who have been declared successful in their qualifying degree exam and will be completing their tenure for the same on or before the closing date of application will be eligible.
- ✓ In cases where result of qualifying degree exam is declared after the closing date of application, their candidature will stand cancelled and no claim for selection on the basis of interview will be considered.

4) OTHER ELIGIBILITY CRITERIA :

1. The date for determination of eligibility with regards to age, educational qualification and experience etc will be the date of closing of online application.
2. MCI / State Medical Council Registration is mandatory before joining, if selected.
3. Those candidates who have already done three (3) terms of Junior Residency anywhere will not be considered.
4. The Screening Committee would be screening the documents submitted by the candidates before the interview and the eligible candidates as declared eligible by the Screening Committee only would be allowed for interview.
5. Mere attending the interview does not guarantee the selection.

Note : Term of Junior Resident (Non-Academic) is 1 year, if any one joins and leaves at any time (in earlier cases also) it will be counted as one term irrespective of duration of work.

5) MODE OF SELECTION :

Selection will be made on the basis of merit assessed through interview. If number of candidates are more, a written test will be conducted. The decision of Executive Director, AIIMS Madurai in this regard shall be final and binding.

6) APPLICATION PROCEDURE :

1. The candidates have to fill the **Google Form**.
2. The applicants have to report at Temporary campus of AIIMS Madurai at Government Medical College Campus, Ramanathapuram, Tamil Nadu on the date of written test / Interview along with the duly filled in Application form and one set of photo copy of self-attested documents along with two passport size photographs.
3. The original certificates as detailed in the **Section 13** of this notification - **“Documents to be produced”** will be verified before written test / interview. After satisfactory screening of the documents as per the notification, the candidate will be considered as eligible for interview.

7) UPPER AGE LIMIT :

1. For eligibility to apply for the post of Junior Resident (Non-Academic), **the upper age limit as on the closing date of application will be 33 years**. The persons belonging to SC / ST / OBC / EWS / PwBD must submit the valid certificate in the requisite proforma duly issued by the authority concerned.
2. The age relaxation for OBC candidates is upto a maximum period of 3 (three) years.
3. The age relaxation for SC / ST candidates is upto a maximum period of 5 (Five) years.
4. In case of candidates with bench mark disability (PwD) - age relaxation is provided up to a maximum period of 10 years for General Category, 13 years for OBC Category (3 years for OBC Category and 10 years for PwBD Category) and 15 years for SC / ST Category (5 years for SC / ST Category and 10 years for PwBD Category).

8) APPLICATION FEE :

The mode of payment is SBI Collect Only (<https://www.onlinesbi.sbi/sbicollect/icollecthome.htm?corpID=6691826>). No other mode of payment (Cheque/MO/IPO/CRF/Cash/Demand Draft, etc.) will be entertained.

Application fee is Rs.500/- for UR / EWS / OBC Category. Application fee is exempted for SC / ST / Women / PwBD (Persons with Benchmark Disability) Candidates. The Application fee is non-refundable.

9) Pay :

Pay Level- 10 (56100 – 177500) of 7th CPC plus usual allowances including NPA (if applicable).

10) VENUE FOR DOCUMENTS VERIFICATION/INTERVIEW/WRITTEN TEST :

Applicants are advised to visit the institute website regularly for update.

12) TERMS & CONDITIONS :

1. The appointment is purely on temporary basis and initially for a period of 01 year. This appointment will not vest any right to claim by the candidate for regular appointment or permanent absorption in the Institute (or) for continued contractual appointment which may be renewed or terminated as decided by the Institute.
2. The contract will automatically expire on completion of 01 year (considered as 1 term) until it is renewed for another term up to a maximum of 3 terms (one and half years including all the terms) on the recommendation of the concerned HoD and the service is required by the Institute. The appointment can be terminated at any time by the Institute without assigning any reason. The employee can also leave the Institute by giving 01 (one) month notice (or) salary in lieu thereof.
3. The initial place of posting of the appointee will be at the temporary campus of AIIMS Madurai i.e., Government Medical College Campus, Ramanathapuram, Tamil Nadu and shall be shifted to Madurai based on the progress of the permanent campus construction at Madurai.

4. The leave entitlement of the appointee shall be governed by the Institute's leave rules as amended from time to time.
5. The Executive Director, AIIMS Madurai reserves the right to cancel the advertisement at any point of time without prior notice (or) fill up less number of posts as advertised depending upon the Institute's requirement.
6. If any candidate who joins the post and leaves / resigns before the completion of the tenure, he / she may do so by giving one month notice as per rules or by depositing pay and allowances with the Institute for the period of which notice falls short of one month. But a candidate can't resign / leave the post within 03 months from the date of joining.
7. The Competent Authority reserves the right to change the number of vacancies, withdraw the process in full or in part and also the right to reject any or all applications received without assigning any reasons or giving notice etc.
8. This appointment is a full-time and private practice of any kind is prohibited.
9. He / She will have to work in shifts and can be posted on rotation at any place including the Trauma & Emergency Medicine in the Institute / Casualty / Ward / OPD / Camps organized by institute or Govt or concerned department as per the need / requirement of Hospital management. He / She may also be posted as casualty medical officer on any day as per the requirement and rotation to conduct casualty admission. During the posting he / she may also be responsible to conduct medico legal examination and reporting also. He / She may also be posted in rural health and urban centre attached with the institute for a period as decided by the institute. He / She is expected to conform to the rules of conduct and discipline as applicable to the institute employees. The appointee shall perform the duties assigned to him / her. The competent authority reserves the right to assign any duty as and when required. No extra / additional allowances will be admissible in case of such assignment.
10. He / She should also note that he / she will have to conform to the rules of discipline and conduct as applicable to the Institute employees.
11. No travelling or other allowances will be paid to the candidate for joining the post.
12. The candidate should not have been convicted by any Court of Law.
13. Candidates working in Government / Semi-Government., PSU should submit "No Objection Certificate" from the present employer. The in-service candidates will not be permitted for interview, if no objection certificate from employer is not produced.
14. Depending upon the requirement, the decision of authorities to increase / decrease number of seats / post shall be final.
15. Canvassing in any form will render the candidate disqualified for the post. The prescribed qualification is minimum and mere possessing the same does not entitle any candidate for selection.

16. In case, any information or declaration given by the candidate is found at any stage to be false or if the candidate has wilfully suppressed any material information relevant to this recruitment at any stage, he/she will be liable to be removed from the service and/or action, as deemed fit, may be taken against him/her by the appointing authority.
17. All information related to this recruitment i.e. Online application procedure, selection procedure, result, corrigendum, addendum etc. will be published on the website of AIIMS Madurai (www.aiimsmadurai.edu.in) from time to time. Hence, the institute will not enter into any correspondence with candidates in such matters. Candidates are advised to regularly visit the website of AIIMS Madurai for updates.
18. Incomplete applications will be summarily rejected.
19. Candidates are advised to visit institute website i.e. <https://aiimsmadurai.edu.in> regularly to get the updates from time to time.
20. All disputes will be subject to jurisdiction of Madurai.
21. Decision of the competent authority of AIIMS Madurai in all matters regarding eligibility / selection would be final and binding on all applicants / candidates.
22. The offer of appointment when made will be provisional and subject to verification of credentials (Educational & Personal) by competent authority.
23. No correspondence whatsoever would be entertained in this regard.
24. The posts of Junior Residents will be regulated as per the provision of Central Residency Scheme.
25. The posts of Junior Resident will be governed by CCS (Temporary Service) Rules.
26. Service under the Institute is governed by that Act and the Rules & Regulations framed thereunder.
27. The appointee shall not be entitled to any benefit like Provident Fund, Pension, Gratuity, Medical Attendance Treatment, Seniority, Promotion etc. or any other benefits available to the Government Servants, appointed on regular basis.
28. The applicant will be responsible for the authenticity of submitted information, other documents and photograph. Submission of any false and / or suppression / concealment of facts shall lead to rejection / cancellation of selection / recruitment.
29. In case of any inadvertent mistake in the process of selection which may be detected at any stage even after the issue of appointment letter, the institute reserves the right to modify / withdraw / cancel any communication made to the candidate.

13) DOCUMENTS TO BE PRODUCED:

The Candidate should bring the following **original documents along with the duly filled in application form (given as Annexure)** and one set of self-attested photocopies at the time of interview at the Institute (to be arranged in the following order):

- e) Class SSC / 10th & 12th Certificates.
- f) MBBS Mark Sheets & Certificates.
- g) Internship Completion Certificate.

- h) FMGE Certificate conducted by NBE (For Foreign Graduate).
- i) Registration with MCI / State Medical Council.
- j) Experience Certificate (copy of completion of Internship).
- k) Reservation category Certificate (OBC*/SC/ST/PwD/EWS)
(*Candidate should belong to non-creamy layer of Central List of OBC).
- l) The Persons with Benchmark Disability (PwBD) certificate should be issued by a duly constituted Medical Board of the State or Central Government Hospitals/Instructions.
- m) All candidates, who want to avail benefit of reservation / age relaxation / exemption offer, should enclose a copy of certificate issued by competent authority in support of their claim for reservation- exemption of fee and relaxation of age.
- n) Self-declaration for no of terms under the Residency Scheme, so far.

Procedure to pay application fee :

3. Search “ALL INDIA INSTITUTE OF MEDICAL SCIENCES, MADURAI”, then “Click”
4. Select "Recruitment Cell - Application Fee" from drop down menu and fill the details.
5. Columns with "*" are mandatory to fill and click "Next" button to verify the information submitted by you and click "Next" button for payment through SBI Net Banking (or) other Banks Net Banking (or) Credit Card (or) Debit Card (or) other payment modes. Transaction charges shall be borne by the applicant.
6. The applicant has to take a print out of the payment receipt and attach along with the online application form.
7. The transaction ID / reference number with the date of payment, amount paid shall be entered in the application on the space provided thereon.
8. Candidates claiming fee exemption shall mention "Fee Exempted" in the fee details space of the respective page of the application form.
9. The fee sent through Money Order, Demand Draft, Bankers Cheque, Indian Postal Orders, Crossed Cheques, Currency Notes, Treasury Challans, etc will not be accepted by the Institute and such applications will be treated as without application fee and will be summarily rejected.
10. Applications not accompanied by full prescribed fee will not be considered and summarily rejected. No representation against such rejection will be entertained.
11. The fees once paid shall not be refunded / adjusted under any circumstances.
12. Candidate is requested to mention the advertisement no {AIIMS-MDU/Recruitment-JR/01-16/2025-26/MARCH-008, dated : 11.03.2026} in the Remarks column while making payment through SBI Collect.

Candidates are requested **NOT TO SEND** hardcopy of application at this stage. Shortlisted candidates have to submit the application form along with self-attested copy of certificates / supporting documents at the time of certificate verification / interview.
