4 **Interview Date, Timing & Venue.** Candidate must reach Stn HQ Shimla at 1000 hrs on **15 Apr 2026** for the interview to be held between 1000 hrs to 1700 hrs. Candidates must bring all the original certificates/mark sheets/degree of 10th /Matric 10+2 & Graduation/post graduation/degree/diploma/course, work experience and discharge book, PPO, service records, Medical certificate and two PP size colour photographs at the time of interview.
