## Recruitment Process for Retail Assets (Secured) Department

Eligible candidates shall apply online between 13<sup>th</sup> April 2026 and 26<sup>th</sup> April 2026 (both days inclusive) through the 'Careers' page of the Bank's website ([federal.bank.in/careers](https://federal.bank.in/careers)) after carefully going through the instructions detailed below.

## 1 Designation

Selected candidates will be considered for various levels in permanent roles under Non-IBA structure, subject to suitability, current role and CTC.

## 2 Domains

- Retail Assets: Housing Loan, Loan Against Property, Auto Loans, etc. - Branch Channel
- Retail Assets: Loan Against Property - DSA Channel

(Note : Candidates shall apply for only one domain)

## 3 Who Can Apply (As on 01.04.2026)

- **Educational Qualification** - Graduation in any stream
- **Age** - Not exceeding 35 years of age (should be born on or after 01.04.1991)
- **Work Experience** – Minimum 2 Years of work experience as Relationship Manager in Mortgage Products
- **Nationality** – Only citizens of India are eligible to apply for the selection process

## 4 Fixed Cost to Company & Other Benefits

The fixed cost to company per annum would be a minimum of ₹4.64 Lakh and maximum of ₹10.06 Lakh depending upon the designation offered, place of posting and other factors.

In addition to this, selected candidates will be eligible for attractive performance linked incentives, will be covered under the National Pension System (NPS) and will also be eligible for other benefits like gratuity, loans on concessional interest rate, medical insurance coverage for self & dependents etc.

- 9.2 There is no application fee for participating in the selection process. No fees shall be paid to any vendor, agency or individual in connection with the selection process.
- 9.3 Candidates have to bear the expenses to attend the selection stages at the stipulated date and time.
- 9.4 Federal Bank reserves the right to make any changes to the selection process at their discretion.
- 9.5 Bank has the right to reject any application / candidature at any stage without assigning any reason and the decision of the Bank shall be final.
