## **(2.2)THE ELIGIBILITY CRITERIA AND QUALIFICATIONS:**

- i. Professor (UG) (Ayurveda):
  - a. Must Posses Post Graduate Degree Qualifications in the subjects/ speciality concerned of any recognised university or any statutory board of State Government, after having undergone regular study of not less than (3) years duration.
  - b. Must have (8) years teaching experience in the subject.
  - c. Must be a permanent Registered Medical Practitioner in the concerned field within the meaning of the Law for the time being existing in the State.
  
- ii. Professor (UG) (Homoeopathy):
  - a. Must Posses Post Graduate Degree Qualifications in the subjects/ speciality concerned of any recognised university or any statutory board of State Government, after having undergone regular study of not less than (3) years duration.
  - b. Must have (8) years teaching experience in the subject.

- c. Must be a permanent Registered Medical Practitioner in the concerned field within the meaning of the Law for the time being existing in the State.
- iii. Associate Professor (Ayurveda):
- Must Posses Post Graduate Degree in (Ayurveda) awarded by a University in India established or in corporate by or under central Act or any Institution recognized by the UGC after having undergone regular study of not less than (3) years duration.
  - Must have (3) years teaching experience in the subject.
  - Must be a permanent Registered Medical Practitioner in the concerned field.
- iv. Associate Professor (Homoeopathy):
- Must Posses Post Graduate Degree in (Homoeopathy) awarded by a University in India established or in corporate by or under central Act or any Institution recognized by the UGC after having undergone regular study of not less than (3) years duration.
  - Must have (3) years teaching experience in the subject.
  - Must be a permanent Registered Medical Practitioner in the concerned field within the meaning of the Law for the time being existing in the State.

**(2.3) Note:**

**a.** In Ayurveda there are no allied subjects and only having PG in concerned subject is eligible.

**b.** In Homoeopathy, allied subjects are as follows:

### 3. Selection procedure

(3.1) Applicants will be selected based on 100 points of which:

(3.1.1) Maximum of 75% will be awarded for percentage of marks obtained in qualifying exam.

(3.1.2) CGPA or Grade Points into percentage of marks the weightage for academic shall be calculated for the 75 points in terms of Govt., Circular Memo.No.01/HM&FW/2022, HM&FW Dept., Dated: 06.09.2022.

**Note: If any applicant not uploaded AYUSH PG Marks Memo their Marks will be read as Zero and treated as "NOT ELIGIBLE"**

(3.1.3) Maximum of 10 points will be awarded for service per completed year after completion of Post Graduation along with requisite qualification.

(3.1.4) Maximum of 15 points will be awarded for working on contract basis with the conditions shown below

#### Particulars of Contract Service Weighage:

1.	@ 5.0 Marks per Six Months of Service for COVID-19 Duties. (0.83 Marks per each completed Month)
2.	@ 2.5 Marks per Six months of service in Tribal Area.
3.	@ 2.0 Marks per Six months of service in Rural Area.
4.	@ 1.0 Marks per Six months of service in Urban Area.
5.	No weightage will be given for the service rendered less than six months and Separate spells cannot be clubbed.
6.	There will be no interview

7.	For availing COVID-19 weight age – <b>COVID-19 appointment orders</b> should be attached to the application along with <b>contract Service certificate</b> and <b>Bank statements indicating payment of Monthly remuneration</b> , if not submitted COVID-19 weight age will not be considered.

- (3.2) Points shall be awarded for service (contract) rendered in state government hospitals/ institutions/ programmes only as per certificates issued by competent authority.
- (3.3) Weightage marks for contract service rendered will be given only for service in the same category of post for which application is made.
- (3.4) The application for seeking Service weightage and the proforma in which Service Certificate shall be issued by respective competent authorities..
- (3.5) Service certificates other than those issued in format specified at Annexure IV will not be taken into consideration.
- (3.6) Date of notification shall be cut off date for calculating the weightage marks
- (3.7) If more than one applicant scores same marks, then the person with higher age will be assigned better higher rank.

**4. AGE :** Maximum of 60 years as on 01-07-2025.

**5.** The applicants who possess requisite qualification should apply online after satisfying themselves about the terms and conditions of this recruitment.

**7. Mode of Fee Payment:**

- (7.1) For payment of fee through the online through payment gateway i.e., Net Banking, Credit Card, Debit Card and Mobile wallet payment, an additional page of the application form will be displayed, wherein candidates may follow the instructions and fill in the requisite details to remit payment.
- (7.2) After submitting the payment information in the online application Form, please wait for the intimation from the server, DO NOT PRESS BACK OR REFRESH BUTTON, in order to avoid double charge.

- (7.3) If the online transaction has been successfully completed final registration number will be generated. Candidates should note the same for future reference.
- (7.4) Candidates should carefully fill in the details in the On-Line application at the appropriate places and click on the "SUBMIT" button at the end of the Online application format. Before presenting the "SUBMIT" button, candidates are advised to verify each and every particular filled in their application.

### **EQUIVALENT QUALIFICATION:**

At the time of verification of certificates, if it is noticed that any applicant who possesses a qualification other than requisite qualification and claims that said qualification is equivalent to the requisite qualification, the matter shall be referred to an 'Expert Committee' constituted by the APMSRB and the APMSRB will take a decision based on the report of the 'Expert Committee'.

#### **Note:**

- (7.1) Provided that the persons referred at S.No.2 in the above table shall, after making deductions referred to in Sub Rule-12(c) (i) & (ii) of Andhra Pradesh State and Subordinate Service Rules, not exceed the maximum age limit prescribed for the post.

### **8. PROCEDURE FOR APPLICATION:**

- (8.1) Application has to be made online on APMSRB website (<https://apmsrb.ap.gov.in/msrb>) only.
- (8.2) Applicants should upload all required certificates (original certificates have to be uploaded for verification at the time of scrutiny before finalizing the selection list).
- (8.3) Applications once submitted online shall be final and no changes shall be permitted thereafter.
- (8.4) Up on submission of online form, Notification wise Application Number shall be generated. The same may be used for any future reference.
- (8.5) Applicant must compulsorily fill-up all relevant columns of the application form carefully. The applicant alone shall be responsible for information provided by them and decisions taken by APMSRB based on the same.

(8.6) Incomplete / incorrect application form will be rejected. The information if any furnished by the applicant subsequently in any form will not be entertained by the APMSRB under any circumstances.

(8.7) The applicant should not furnish any particulars that are false, tampered, fabricated, or suppress any material information while submitting online application. The applicant shall be liable for legal action in such cases.

## **9. RESERVATIONS: -**

The Rule of Reservation is applicable as issued by state government from time to time.

## **10. COMMUNITY CERTIFICATE:**

(10.1) Applicants belonging to Schedule Classes are required to produce Community Certificate (SC-I, SC-II and SC-III) issued by the Competent Authority of Government of Andhra Pradesh Read Go.Ms.No.46, General Administration (Ser-D) Dept., Dated: 19.04.2005 and G.O. Ms No.7, Social Welfare (CV) Dept., Dated: 18.04.2025.

(10.2) Certificates issued by competent authorities of Government of Andhra Pradesh will only be considered.

(10.3) Applicants belonging to states other than Andhra Pradesh are not entitled to any kind of reservation.

## **11. RESERVATION TO LOCAL CANDIDATES**

### **(11.1) LOCAL CANDIDATURE**

- Candidates who are Local to Andhra Pradesh are only eligible for the posts reserved for local category. (Candidates who studied from 4th Class to 10th Class in the State of Andhra Pradesh and candidates who migrated to any part of Andhra Pradesh from the State of Telangana within a period of 3 years from 2<sup>nd</sup> June 2014. (As per G.O.No.132 GAD Dt.13-6-2016 & G.O.Ms.No.133 GAD Dt.13.06.2016)
- The Residence Certificate issued by MRO/ Tahsildar will not be allowed for Local consideration without mentioning the G.O.No.132 GAD Dt.13-6-2016 & G.O.Ms.No.133 GAD Dt.13.06.2016 for the candidate who studied in the state of Telangana before bifurcation.
- "Local Candidate" means a candidate for direct recruitment to any of the post in relation to those Local areas where he/she has studied in Educational Institution(s) for not less than four consecutive academic years prior to and including the year in which

he/she appeared for SSC or its equivalent examination. If however, he/she has not studied in any educational Institution during the above four years period, it is enough if he/she has resided in that area which is claimed as his/her local area during the above said period.

(11.2) Residence certificate will not be accepted, if a candidate who studied in any Educational institutions up to S.S.C. or equivalent examination, such candidates have to produce study certificates invariably.

## **12. CERTIFICATES TO BE UPLOADED ONLINE:**

Candidates shall submit the application online uploading following certificates in support of their claims in the application

- SSC Certificates (proof of date of birth)\*
- Study Certificates from class 4th to 10th from the school where the candidate studied. If SSC or its equivalent done by private study, without attending any school, Residence certificate from MRO for previous 7 years. (In the prescribed Proforma). In the absence of the above certificate the candidate will be considered as Non- Local.
- Intermediate certificate\*
- Post Graduate Degree Marks Memo with Internship certificate to be uploaded in Original\*
- Permanent Registered Medical Practitioner in the concerned field within the meaning of the Law.
- Contract Service Certificate if any
- Social status / Caste Certificate in case of candidates who claim reservation. If social status certificate is NOT submitted, then such candidate is treated as OC.
