India Security Press, Nashik Road is one of the nine units under the "Security Printing and Minting Corporation of India Limited (SPMCIL)" a Mini Ratna Category-I, Central Public Sector Enterprise Company, a wholly owned company of Government of India, incorporated on 13th January, 2006 under the companies Act, 1956 with the objective of designing, manufacturing of different security documents including Passport, Stamp Paper, Non-Judicial Stamp Papers, Postal Stamps, MICR Cheques, electoral stationery etc. SPMCIL is under the administrative control of Department of Economic Affairs, Ministry of Finance having its registered and Corporate Office at Third floor, Tower-G, World Trade Center, Nauroji Nagar, New Delhi – 110029.

With the above background, India Security Press, Nashik invites applications for empanelment as Consultants (Civil) on day-to-day need basis from retired Govt. Servants/ PSU employees or serving / retired faculty in Govt. Institution (as Domain Experts) or any Private Qualified Consultant for the Civil Works Panel in the India Security Press, Nashik Road for a period of one year, which can be extended by another one year subject to performance.

HOW TO APPLY:

1. The application should be submitted in the Proforma given in the advertisement, preferably type written.
2. The outer cover should be subscribed as "APPLICATION FOR EMPANELMENT AS CONSULTANT (CIVIL) for Civil Works Panel on DAY-TO -DAY need Basis".
3. The application should be accompanied with self-attested copies of certificates in support of educational qualification, age and experience.
4. Duly completed application should be sent to the Chief General Manager, India Security Press, Nashik Road - 422101 **on or before 15.05.2026**. Applications received late/incomplete will be rejected. India Security Press (ISP) Management will not be responsible for any postal delay/loss of documents during transit.

GENERAL CONDITIONS:

ELIGIBILITY CRITERIA FOR INDIVIDUAL CIVIL WORKS CONSULTANT

1. Educational Qualification

- 1.1 The applicant must possess a Bachelor's Degree in Civil Engineering (B.E./B.Tech) from a recognized university or institution in India.
- 1.1.1 Preferences shall be given to Postgraduate qualification (M.E./M.Tech) in Civil Engineering, Structural Engineering, Construction Management, or Infrastructure Engineering will be considered desirable.

2. Minimum Professional Experience

- 2.1 The applicant must have a minimum of 20 years of professional experience in civil engineering works in India.
- 2.2 Experience should preferably be in:
 - Central Government Departments
 - State Government Departments
 - Public Sector Undertakings (PSUs)
 - Autonomous bodies
 - Government-funded institutions or authorities.

3. Relevant Technical Experience

The consultant must have demonstrated experience in one or more of the following areas of civil engineering projects:

- a) Project Planning and Design
- b) Preparation and review of Detailed Project Reports (DPRs).
- c) Preparation of cost estimates, bill of quantities (BOQ), and technical specifications.
- d) Supervision and monitoring of construction activities.
- e) Conducting site inspections and technical evaluations.

4. Senior Level Position Experience

The applicant must have held senior engineering or managerial positions during their service career or have undertaken works/**rendered** consultancy of the nature as mentioned at Para '3' above for at least 5 projects of value Rs. 10 Crore and above preferably for government departments/PSUs. Eligible positions held may include:

- a) Superintending Engineer
- b) Executive Engineer
- c) General Manager (Civil) in PSU
- d) Additional General Manager (Civil) in PSU

5. Knowledge of Government Procedures and Standards

The consultant should have working knowledge of the following:

- a) Government procurement procedures
- b) Tendering and contract management
- c) Public works construction standards
- d) Government project monitoring systems.
- e) Knowledge of the following guidelines is desirable:
- f) General Financial Rules (GFR)
- g) CPWD Works Manual
- h) CVC procurement guidelines
- i) Standard bidding documents used in government projects.

6. Age Limit

- a) The consultant should preferably be not more than 65 years of age as on last date of application i.e. 15.05.2026.
- b) The consultant must be medically fit and capable of undertaking field visits and technical inspections.

7. Integrity and Service Record

- The applicant must have retired from government service or PSU with a clean and satisfactory service record. (Applicable for retired government servant)
- The candidate must not have been dismissed, removed, or compulsorily retired due to disciplinary action at any point of time in his/her career.
- The applicant must declare that:
 - a) No vigilance or disciplinary case is pending.
 - b) No criminal case or investigation is pending.
 - c) The individual or his/her firm has not been blacklisted by any government department/entity at any point of time. (In case of private applicants)

The Consultant may be engaged for the following responsibilities:

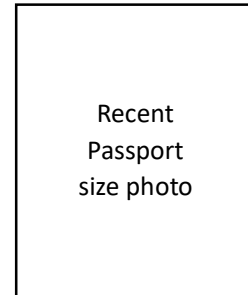
- a) Technical review of DPRs and civil engineering proposals.
