*Note: The qualifying/eligibility service shall continue to be 3 years for Limited Departmental Examination for persons holding posts in the UDC grade on regular basis on the date of notification of the extant rules as notified in the Mizoram Gazette extraordinary Issue No. 577 Vide No. A.12018/31/2020-PAR(GSW) dt. 30.11.2021.*
7. **Last Date of Application** : **12.06.2026 till 4:00 PM**

**9. Disqualifications :**

- (i) Canvassing(**insawipui**) by a candidate directly or indirectly will disqualify his/her candidature.
- (ii) Particulars/Details to be mentioned in the application should be completely and correctly stated. Any application not specifying the required information of a concerned candidate shall be liable to be rejected.
- (iii) **Any in, on verification at any stage of the recruitment process, does not fulfill any of the eligibility conditions will be disqualified.**
- (iv) **To support their application, the candidates must upload/submit the following before the last day of application; failure of the same will result in disqualification of the candidate. And any application for alteration of documents already uploaded by the candidate in the online portal should be made before the last date of application. Documents to be uploaded are:-**
  - (a) Confirmation Order.
  - (b) Joining Report/Service Book Entry showing date of joining the feeder post.
  - (c) Certification by HoD or Cadre Authority.

**10. If payment is to be done through UPI, it may be done using only the mobile number used for one time registration. Persons with disabilities are exempted from payment of application fees. Fees once paid is non-refundable under any circumstances.**
