The persons applying for the services as Member in Permanent Lok Adalat, Thanjavur should have the following;

Qualification:

1. He / She must be a citizen of India and Local resident of Thanjavur District.
2. He / She should pass minimum degree standard as on the date of notification and must have ability to write and speak the local language fluently.

Preference will be given to Retired Teachers from Govt /Private Schools, Retired Government servants worked in postal, telephone, electricity, civil supplies, municipal, transport corporation, Housing Board, Insurance personals, Doctors/Physicians, Services Oriented NGO's.

3. The minimum age for the selection of member should not be less than 21 years and below 62 years as on the date of Notification.
4. He / She must have an experience in Public Utility Service defined under section 22 A (b) of The Legal Services Authorities Act, 1987 of not less than 10 years.

Explanation: The Public Utility Services are as follows

1. Transport services (Air, Road or Water); or
2. Postal, Telegraph or Telephone services; or
3. Supply of power, light or water to the public by any establishment; or
4. Public Conservancy or Sanitation; or
5. Service in the hospital or dispensary; or
6. Insurance Service,
7. Education or Educational Institutions; or
8. Housing and Real Estate Service.

Disqualification:

The selected persons as Member shall be disqualified and removed from the post if he/she;

- ❖ Adjudged as an insolvent.
- ❖ Has been convicted of an offence and involves moral turpitude.
- ❖ Has become physically or mentally incapable of acting as member.
- ❖ If he/she is an active political enthusiast of a political party.
- ❖ Has or so abused his position as to render his continuance in office prejudicial to the public interest.

Important Information:

- ❖ The Member in Permanent Lok Adalat will have to sit the whole day and will have to work as a full-time worker.
- ❖ The selected applicant shall give undertaking that they will not have any other work other than the work in PLA during their tenure as Member.

- ❖ The selected applicant shall give undertaking that they do not and will have any financial or other interest as is likely to affect prejudicially in his/her function in PLA.
- ❖ The applicant must have the unflinching commitment towards the cause which should be translated into the work they undertake.
- ❖ The applicant should have mindset to assist for arrive compromise or settlement in the matter connected with public utility service with compassion, empathy and concern over them.
- ❖ The member shall hold office for a term of 5 years or till the age of 65 years, whichever is earlier.

Remuneration:

The service as Member of Permanent Lok Adalat (PLA) entitled sitting fee of Rs.1500/- (Rupees One Thousand Five Hundred) per sitting in view of Rule 3 (b) of The Permanent Lok Adalat (other terms and conditions of Appointment of Chairman and other Persons) Amendment Rules, 2016.

How to Apply:

The standard form of application annexed with this notification shall be used for apply the post along with two number of passport photographs and the applicants shall enclose self-attested photocopies of Educational/Employment along with experience certificate if any (Through post only).

Procedure for selection:


- The list of eligible persons will be called for an interview and they will be selected as per their experience in Public Utility Service and efficiency and the decision of the selection committee shall be final in this regard.
- In case, any objection regarding selection of Member in PLA, the decision of the Chairman, District Legal Services Authority, Thanjavur shall be final and binding to all concerned.
- No TA/DA will be provided for appearing in the interview.
- Application containing wrong particulars will be liable for rejection.
- Canvassing directly or indirectly will disqualify the candidate.

Submission of Application:

The applications should reach the Office of "CHAIRMAN/PRINCIPAL DISTRICT JUDGE, District Legal Services Authority, ADR Building, Combined Court Campus, Thanjavur-613007 on or before 31-05-2026. The applicants should submit the mobile/contact number in their applications for further required communication, if any.

Incomplete application will be rejected without assigning any reasons. No application will be entertained after the last date fixed.
