- Rules of Reservation will be implemented as per Govt. of India instructions.
- The appointment shall not confer any right or preference for regular appointment.
- No claim for any service benefit like, PF, Pension, Gratuity, Medical Allowance, Seniority, Promotion and Leave will be admissible.
- Selected candidates are eligible for 1 day leave per month.
- Candidates must be registered with Karnataka Medical Council or MCI before joining the post.
- Candidates in the Government Service should submit "No Objection Certificate" from the employer at the time of interview.
- No TA/DA will be admissible for interview or joining.
- ESI Corporation may increase or decrease or cancel filling up of any post without assigning any reasons at the discretion of the Appointing Authority.
- The application should be submitted in the prescribed format only. If the applications found incomplete will be summarily rejected.
- The candidates claiming reservation/age relaxation on grounds of belonging to OBC

should submit the Community Certificate in **Annexure "A"** prescribed vide Govt. of India, Department of Personnel and Training O.M No. 36036/2/2013-Estt.(Res.), dated 30.05.2014 failing which the benefit of reservation/ relaxation will not be given and their application shall be rejected and no request / correspondence will be entertained. 16.Selected candidates **have to deposit an amount of Rs. 1,00,000/- as refundable Security deposit (non interest bearing) (Drawn in favour of ESIC Fund A/C No.1).** However, this amount will be appropriated towards administrative cost in case, the candidate resigns/terminates his/her contract ESIC terminates the contract on account of any misconduct **within Six months** of the commencement of the contract with or without prior notice or non fulfilment of Notice period conditions.

17.This being a contract appointment for One year, absence for a period beyond 15 days will be treated as abandonment of duty and the contract will be terminated without any reason and the security deposit of Rs. 1,00,000/- will be forfeited.

Duly filled in application form in the prescribed format (ailable on website www.esic.gov.in)should be brought during the walk in interview with all the original certificates such as Matriculation Certificate (for proof of age), MBBS, Registration certificate with the KMC/MCI etc. and two passport size photographs along with 1 set of photocopies of all the certificates.

2. In case of turnout of candidates is more, the competent authority at their own discretion shall conduct a screening test to shortlist the candidates for the interview.
  - a. The screening test will consist of multiple choice questions in the concerned discipline and ESIC Related.
  - b. There will be NEGATIVE marking for the MCQs.
  - c. The marks obtained in the screening test will not in any way be linked to the final selection process.
  - d. The performance of the candidate in the interview will be the sole criteria for selecting the candidate for the respective post. Merit participation in the screening test will not confer any claim for the post.
