**a. Selection Criteria for the Trainee posts viz. TMEs, TELOs and NCV(T)s:**

- i. The selection is based on the percentage of marks obtained in the prescribed qualification mentioned above and performance in Interview for Trainee Marine Engineers and TELOs. For candidates who have completed Graduate Marine Engineering, prescribed qualification for calculating percentage of marks will be based on four-year Degree in Engineering.
- ii. Total marks for selection – 100 marks
- iii. 80% weightage will be given for marks obtained in the prescribed qualification and 20% weightage will be given for interview.
- iv. Minimum cut-off marks for the selection is 50% each in prescribed qualification and interview (i.e., 40 marks out of 80 in prescribed qualification & 10 marks out of 20 in interview).

- v. The Selection is based on the percentage of marks obtained in the prescribed qualification mentioned above for NCV(Trainee). 50% weightage will be given for marks obtained in SSC/ 10<sup>th</sup> Class and 50% weightage will be given for GPR Exit Examination.

- iv. The period of training will be 12 months for Trainee SHM/ Trainee ERR and 06 months for Trainee COOK.
