Tata Memorial Centre, Mumbai, invites applications from Indian Nationals for the posts of **Senior Resident in Oral Oncology Reconstructive Surgery** in the Department of **Head & Neck Surgery** for **Homi Bhabha Cancer Hospital and Mahamana Pandit Madan Mohan Malaviya Cancer Centre, Varanasi**. The advertised post is tenured (non-permanent) position for one year commencing from **01<sup>st</sup> August 2026**. The details are as follows: -

**GENERAL CONDITIONS:**

1. **AGE LIMIT:** 40 YEARS. (Relaxable by 5 years for SC/ST, 3 years for OBC & 10 years for Physically Handicapped).
2. **Age & experience will be reckoned as on 15.06.2026.**
3. **Security/ Caution Deposit:** Senior resident is Rs.1,33,623/-
4. **SALARY:** Senior Resident will be offered a monthly consolidated salary of ₹ 1,33,623/- (Rupees One Lakh Thirty-Three Thousand Six Hundred Twenty - Three only).
5. SRs may be provided shared accommodation subject to availability. Hostel Charges will be deducted monthly from the stipend/salary.
6. All UG, PG & Super-Specialty degrees must be recognized by the Dental Council of India. It is mandatory for all candidates selected and appointed in HBCH/MPMMCC to be registered with Uttar Pradesh Dental Council.
7. The candidates currently employed in a government or related organization (Central / State Government / Autonomous Body / Semi Government Organization) they must obtain a No Objection Certificate from their employer. The NOC should be issued through the Head of their Institution/Department. The candidate must upload the NOC as part of the application process. Additionally, they must bring the original NOC document when appearing for the MCQ Test or interview, failing to produce the candidate not being allowed to appear for the MCQ/interview.
8. Online application will be available on the website of Tata Memorial Centre, Mumbai and can be accessed by clicking the link: <https://tmc.gov.in/postmaster/Careers>. Online application in the prescribed form must be filled out completely in all respect.

- Incomplete applications will be rejected. The Tata Memorial Centre also reserves the right to reject any or all the applications without assigning any reasons thereof. No other mode of application will be accepted. Separate application should be submitted for each post.
9. Candidates shall pay the online **application fee of Rs.300/-** by using Debit / Credit Card or UPI. The application fee once paid will not be refunded under any circumstances. Candidates must ensure that they fulfill the eligibility criteria before applying for the post and making payment. Any Duplication payment of fees will not be refunded.
  10. The Online application form must be filled out completely in all respects. Incomplete applications will be rejected. No other mode of application will be accepted.
  11. Candidates whose results are awaited may apply for the above post (where applicable); however, they must produce proof of having passed the required degree on the day of the MCQ/Interview. Candidates, who fail to submit such proof will not be allowed to appear for the MCQ/Interview.
  12. The last date for submission of the online application is **15.06.2026 up to 05.30 p.m.** (Indian Standard Time). Candidates are advised to submit their application well in advance without waiting for the closing date. Candidates are “NOT” required to submit or send a hard copy of the application form.
  13. Candidates must submit documentary evidence in support of the details furnished in the online application form including proof of date of birth, qualifications, experience, caste, disability certificate, NOC etc., failing to provide such documents will be treated as incomplete and summarily rejected.
  14. Tata Memorial Centre reserves the right to cancel the posts, fix minimum eligibility standards /benchmarks and restrict the number of candidates called for the MCQ/interview taking into account factors such as the number of vacancies and candidates performance. The Centre also reserves the right to determine the qualifying marks for selecting candidates for the interview. Merely fulfilling the prescribed qualifications will not entitle an applicant to be called for the MCQ/interview. Further the Centre may fix minimum eligibility standards or cut-off marks (Group/Stream/Discipline/Category-wise etc.) for shortlisting candidates for interview and for final selection after the interview. The decision of the Director of the HBCH/MPMMCC in this regards shall be final and no representation will be entertained in this regard.
  15. All correspondence with applicants will be done via the e-mail ID [resident@mpmmcc.tmc.gov.in](mailto:resident@mpmmcc.tmc.gov.in) . The Centre will not be responsible for non-receipt of application due to online submission errors, incorrect e-mail IDs provided by candidates or e-mails being delivered to spam/bulk folders. All applicants must provide their latest mobile number and valid e-mail ID to ensure timely communication.
  16. The MCQ examination will be conducted only if the number of applicants exceeds three times the number of posts advertised. If the number of applications received for a post is fewer than the number of vacancies, no MCQ test will be held for that post. The Dean (Academics), HBCH/MPMMCC will have the discretion to decide for which posts the MCQ examination will be conducted and for which posts it will not be held. The decision of the Dean (Academics), HBCH/MPMMCC will be final.
  17. No TA/DA (Travel Allowance / Dearness Allowance) will be admissible for candidates appearing for the MCQ/interview.
  18. Application will be rejected if a candidate provides incorrect or false information in the application form. No correspondence in this regard will be entertained.
  19. **Legal jurisdiction:** Legal jurisdiction for any dispute will be at Varanasi only.
