This office will not be responsible for any postal delay if applications are received after due date.

4. **Computer Literacy.** Person having computer knowledge including MS Word, Powerpoint and excel will be given preference.

5. The appointment must be willing for multitasking. Written test /Practical exams will be conducted to candidates at the time of interview.

6. **Interview, Date , timing & Venue.** Interview for short listed candidates will be conducted in the Third/Fourth week of Jun 2026. Confirm dt will be intimated telephonically. No TA/DA is admissible. Applicants must furnish their Tele Number and e-mail ID in the application. Only candidates meeting the Qualitative Requirements should apply.
