Section 18(7) and (8) of the Bharatiya Nagarik Suraksha Sanhita, 2023 stipulates that an Advocate who has been in Practice for not less than seven

years may be appointed as Public Prosecutor or an Additional Public Prosecutor and not less than ten years may be appointed as Special Public Prosecutor.

Hence, Advocates in Tamil Nadu Courts with not less than Seven Years/Ten Years experience and who are willing to accept the post are requested to express their willingness in writing to the undersigned by furnishing the particulars in the prescribed Application Form in Annexure I and II with two passport size photographs to this office, and the application should reach this office on or before 24.06.2026.

The applications received after 5.45 PM on 24.06.2026 will not be considered.
