NOTIFICATION

The Government have called for a panel of Advocates for filling up the posts of Law Officers in the Subordinate Courts in The Nilgiris District. The law officers will be appointed on tenure basis.

Section 18(3), (4) and (5) of the Bharatiya Nagarik Suraksha Sanhita, 2023 stipulates that an Advocate who has been in practice for not less than **seven** years may be appointed as Law Officers in the Subordinate Courts in The Nilgiris District. The appointment of the Law Officers to the above posts may be terminated by the Government at any time.

Hence, advocates in Tamil Nadu Courts who have put in not less than seven years of standing at the bar and who are willing to apply to the post are requested to submit application in form Annexure-I & II in six copies with two passport size photographs. The application should reach this office on or before 5.45 P.M., on 23.06.2026. The application received after 5.45 P.M., on 23.06.2026 will not be entertained and it will be summarily rejected.
