

NOTIFICATION

The Government have called for a panel of names of Advocates for filling up the post of Law Officers in Various District / Subordinate Courts in Madurai District on a tenure basis for a period of three years as per the provisions contained in Section 18 (3), (4) and (5) of the Bharatiya Nagarik Suraksha Sanhita, 2023. Section 18 (3), (4) and (5) of the Bharatiya Nagarik Suraksha Sanhita, 2023 stipulates that an Advocate who has been in practice for not less than seven years may be appointed as Public Prosecutor or an Additional Public Prosecutor, and not less than ten years may be appointed as Special Public Prosecutor.

Hence, Advocates in Tamil Nadu Courts with not less than Seven years /Ten years' standing at the Bar and who are willing to accept the post are requested to express their willingness in writing to the undersigned, furnishing the particulars in the prescribed **Application form in Annexure I and II, six copies with two passport-size photographs to this office, to reach this office on or before 29-06-2026.**

The applications received after 5.45 p.m. on 29-06-2026 will not be entertained, and they will be summarily rejected.
