
The law officers will be appointed to the aforesaid post on tenure basis for the period as notified by the Government and the law officers may be terminated by the Government at any time without any prior intimation. After appointment the law officer may also resign his/her post if he/she decides to do so by giving one month prior notice to the Government in writing.

Section 18(3) (4),(5)(7)and (8) of the Bharatiya Nagarik Suraksha Sanhita, 2023 stipulates that an advocate who has been in practice for **not less than Seven years** may be appointed as **Public Prosecutor** or an **Additional Public Prosecutor** and an advocate who has been in practice for **not less than 10 years** may be appointed as **Special Public Prosecutor**. Further **Section 10-A** of **G.O.(Ms).No.4054**, Home Department, Dated: 18.11.1961 states that an advocate with **not less than Seven years** of standing at the Bar of the Madras High Court, shall be appointed as **Government Pleader, Public Prosecutor or as an Additional Public Prosecutor**.

In this regard, the advocates, who are willing to accept the aforesaid posts are instructed to furnish the particulars in the prescribed application form as **Annexures I and II (in six copies)** along with the certificates related to their educational qualification, age, community and service in the Bar etc. and 3 recent passport size photographs should be sent to this office **on or before 30.06.2026 by 05:45 PM** (Copies of necessary certificates and supporting documents must be enclosed along with the application).

The applications received **after the due date (i,e 30.06.2026-05:45 PM)** will not be considered.
