Section 18 (3), (4) and (5) of the Bharatiya Nagarik Suraksha Sanhita, 2023 stipulates that an Advocate who has been in practice for not

less than seven years may be appointed as Public Prosecutor or an Additional Public Prosecutor and not less than ten years may be appointed as Special Public Prosecutor.

Hence, Advocates in Tamil Nadu with not less than seven years/ Ten years standing at the Bar council, who are willing to accept the post are requested to express their willingness in writing to the undersigned, furnishing the particulars required in the prescribed application form in **Annexure – I and II in six copies with passport size photographs so as to reach this office on or before 5.45.P.M. on 30.06.2026.**

The applications received after 5.45 P.M. on 30.06.2026 will not be considered.
