Section 18(7) and 8 of the code of Bharatiya Nagarik Suraksha Sanhita, 2023 stipulates that an Advocate who has been in practice for not less than **SEVEN YEARS** may be appointed as Public Prosecutor or an Additional Public Prosecutor and not less than **TEN YEARS** may be appointed as Special Public Prosecutor.

The Advocates in Tamil Nadu Courts with not less than seven years of experience at the Bar and who are willing to accept the post, are requested to send their application in writing furnishing the required Bio-data particulars in the Application Form (Annexure I & II) **six copies** with passport size photograph so as to reach this office on or before 6.00 PM on **25.06.2026**. The xerox copies of certificates/ supporting documents should also be enclosed along with application.

4. The application should reach this office on or before 6.00 PM on **25.06.2026** in person or through registered post. Any application received after the stipulated time will not be considered.
