"WALK-IN-INTERVIEW"

It has been decided to engage 'Contract Medical Practitioners (CMP)' GDMO on full time contract basis in Khurda Road Division, East Coast Railway, from willing, eligible Doctors as per the scheme provided by the Railway Board, from time to time, or till the posts are filled up by regular IRMS (now IRHS) Doctors, whichever is earlier. A Walk-in-Interview will be conducted to adjudge the suitability of the willing doctors, the date/time/venue of which is provided below. The details of the scheme are given below:-

TOTAL NO OF VACANCIES.- 02 CMPs (GDMO) (01 each at HU/PUI & HU/KDJR)

Community wise break-up of vacancies are proposed to be filled up as UR-1 & OBC-1.

N.B : 1. The vacancies may alter as per administrative requirement at any time during the engagement.

2. The administration, however, reserves the right to place the engaged CMPs anywhere in the jurisdiction of ECoR (KUR Division).

3. Retired railway doctors, retired government medical doctors of State Government and Central Government who are physically fit up to 65 years of age are also eligible.

EDUCATIONAL QUALIFICATION/ELIGIBILITY:

The candidate should be a minimum MBBS pass degree from an institute recognized by the Indian Medical Council and with registration in Indian Medical Council, or with a valid registration certificate of any of the State Medical Council of India after completion of one year of compulsory, rotatory Internship. No other certificate will be accepted. Higher qualification, if any, will be given due preference.

AGE (i) Not exceeding 60 years of age as on 01.06.2026. However, age relaxation is admissible for 5 years for SC/ST category candidates and 3 years for OBC category candidates.

(ii) For retired Railway Doctors, retired Government Medical Doctors of State Governments and Central Government, age to be considered is 65 years as on 01.06.2026.

REMUNERATION :

- Monthly remuneration is ₹95,000/-(including HRA & Transport Allowance) for Full Time General Duty Medical Officer (GDMO).
- For retired Railway Doctors, retired Government Medical Doctors of State Government and Central Government, the monthly remuneration, as decided by Railway Board, is subject to the condition that the pension plus contractual remuneration of the retired Doctors should not exceed than the last pay drawn at the time of retirement. No Dearness and any other allowances which are admissible to regular Railway Servants shall be admissible.
- Normally Sundays and National Holidays will be off and in addition, sanctioned leave without detriment to the terms shall be allowed at the rate of two days per month to be availed any time during the contract to the extent earned by the CMP till such time subject to fulfilment of other conditions. Daily rate of proportionate reduction from the remuneration in the event of excess absence will be applicable.
- In case a railway accommodation is provided to the CMP, an amount equivalent to HRA (as per the middle slab, i.e., 18% under 7th CPC) along with the applicable license fee of the accommodation shall be deducted from the monthly remuneration payable to CMPs as per Railway Board's letter No.2020/E(GR)IU/1/2 dated 04.07.2022.

VENUE , DATE AND TIME OF WALK-IN INTERVIEW:

Eligible and willing candidates should report at the venue given below along with the original certificates and self attested photocopies of certificates showing date of birth, educational qualification, community and two recent passport size photographs. Besides these, retired doctors should bring original P.P.O.(Pension Payment Order), Service Certificate & LPC along with attested photo copies of all.

OTHER TERMS AND CONDITIONS :

- (i) Selected candidates will be subjected to medical examination and only medically fit candidates will be engaged as CMP. At the time of entering into the contract, the CMP shall produce certificate of his/her character and antecedents certified by Gazetted Officer of the Central/State Govt.
- (ii) The full time Contract Medical Practitioner who enters contract with Railways will not have any claim or right for his/her continuity or automatic extension of the term of contract. Engagement as CMP will not confer any right for automatic regularization, or absorption in the railway.
- (iii) During the validity of the contract, the CMP will be at liberty to terminate the contract for betterment of his/her career or any other ground by giving 15 days prior notice to the Railways. The contract can also be terminated by the Railway at any time during the contract by giving 15 days notice without assigning any reasons whatsoever. The contract shall also be terminated by the Railway Administration if the CMP is found to be mentally or physically incapacitated. On joining of regular IRHS Doctor(s) in the Division, the engagement shall be automatically terminated in the same fashion as would be decided by the administration.
- (iv) The CMP may avail free medical treatment for self only except operations categorized as 'special' in para 622(8) of IRMM 2000 and treatment normally available at super specialty centre in his/her respective zonal railway hospitals during the currency of contract.
- (v) The detailed instructions with regard to the duties while in contract in Railways shall be given to CMP concerned in the event of selection along with the offer of engagement.
- (vi) Appearance in the interview will not vest any right upon the candidate to be engaged as CMP and no reason(s) will be cited or communication shall be made with the candidate in the event of candidate not getting selected.
- (vii) The administration of the ECoR/Khurda Road reserves absolute rights to cancel this notification without assigning any reason(s).
- (viii) One set 1st class complimentary Railway pass for self and family during each contractual year shall be issued after 03 months continuous engagement.
- (ix) No Railway Privilege Passes/PTOs shall be admissible to retired Railway Doctors engaged as CMP in his/her capacity of CMP.
- (x) Duty passes as per eligibility would be provided for outstation duties to the CMPs.
- (xi) The applicants may indicate their preference of posting in the Application Form. However, this is not binding on the administration and they are liable to be posted as per administrative requirement.
