Section 18 (7) and (8) of the Bharatiya Nagarik Suraksha Sanhita, 2023 stipulates that an Advocate who has been in practice for not less than seven years may be appointed as Public Prosecutor or an Additional Public Prosecutor and those who have been practice for not less than ten years may be appointed as Special Public Prosecutor.

Hence, Advocates in Tamil Nadu Courts with not less than Seven years / Ten years standing and who are willing to accept the post are requested to express their willingness in writing to the undersigned, furnishing the particulars in the prescribed application form in Annexure I and II (Six copies) with three recent passport size photographs to this office, so as to reach this office on or before **29.06.2026**.

The applications received after **5.45 P.M on 29.06.2026** will not be considered.
