**1. TENURE OF ENGAGEMENT:**

The tenure of engagement shall be for a period of 15 years or till the date of superannuation (60 Years) whichever is earlier. However, the tenure of engagement shall be reviewed for extension based on individual performance and project requirements on completion of every 5 years.

**2. UPPER AGE LIMIT as on 01.06.2026 for :**

- PwBD candidate: Relaxation permitted in the respective category will be as per Govt. of India Rules.



### **3. PAY SCALE:**

Selected candidates will be inducted in the pay scales as mentioned above. In addition to Basic Pay, other allowance like Dearness Allowance, House Rent Allowance, Perquisites at the rate of 35% of the annual basic pay, reimbursement of medical expenses, Group Insurance, PF, Gratuity, PRP etc. as per Company rules will be a part of remuneration package.

### **4. QUALIFICATION & EXPERIENCE:**

Candidates should have secured Pass Class in Diploma in Engineering or equivalent in the following disciplines

- a) Electronics/Electronics & Communication/Electronics and Telecommunication/ Communication/ Telecommunication
- b) Electrical
- c) Mechanical

And the reservation is 100% for Ex-servicemen.

#### **EXPERIENCE REQUIRED:**

Should be in the rank of JR. COMMISSIONED OFFICER (JCO) with 15 years of service from Indian Army/Navy/Air Force along with desired qualification as mentioned above

Candidate should be discharged from service as on or after **01.06.2021**.

- Knowledge on operations and maintenance of electrical/electronic equipments in Army/Air force /Naval systems
- Experience in Battle Tanks /Gunnery will be desired

### **5. METHOD OF SELECTION:**

Selection will be through a written test followed by Interview for those who qualify in written test in ratio of 1:7 (as per the vacancy in category).

## 8. DOCUMENTS TO BE SUBMITTED:

**The self-attested photocopies (legible & complete) of the following documents should be enclosed along with the application form:**

- a. Recent color passport size photographs.
- b. SSLC/ SSC / 10<sup>th</sup> Standard Marks Card (proof of age)
- c. Self-attested copies of certificate and marks card for having passed all semesters/years of diploma Engineering or equivalent examination.
- d. Aadhaar Card / Driving License / Pan Card / Voter ID Copy for Identify Proof.
- e. Discharge book / certificate issued by the Indian Defence Forces clearly indicating the medical category, date of discharge and Exemplary/Very Good OR Equivalent record.
- f. Candidates need to submit copies of the relevant caste / tribe /community certificate issued by the competent authority, if applicable.
- g. Disability certificate/ Caste certificate in case of OBC (NCL)/ SC/ ST (if applicable, strictly in the prescribed formats, which are available on the BEL website). Candidates belonging to OBC-NCL category should produce the Certificate issued on or after **01.06.2025**.
- h. Experience Certificates from previous employer's/ Appointment letter/ Latest Salary Slip in case of present employer.
- i. Candidates who are employed in Govt. / Quasi Govt. / Public Sector Undertakings are required to submit their applications through proper channel or attach No Objection Certificate along with Application form.
- j. Proforma of certificate for Employed officials- (Download & Fill the Annexure Available in BEL website and attach with the application form).
- k. Form of undertaking to be given by candidate applying for civil posts under Ex-Servicemen category (Download & Fill the Annexure Available in BEL website and attach with the application form).
- l. Failure to forward the indicated enclosures will result in disqualification.



## **9. GENERAL INSTRUCTIONS:**

- a. Only Indian Nationals are eligible to apply.
- b. There is no application fee for Ex-servicemen posts
- c. Before applying for the post, the candidates should ensure that they fulfill the eligibility criteria mentioned in the advertisement.
- d. The candidates have to produce a valid photo identity proof while appearing for the Written Test.
- e. Candidates with Disability of not less than 40% only will be eligible for reservation and relaxation as PwBD. PwBD candidates are required to submit disability certificate issued by the Medical Board in the prescribed format (available in Company's website [www.bel-india.in](http://www.bel-india.in)) along with the application.
- f. Applicants should have sound health. No relaxation in health standard is allowed. Appointment of selected candidates will be subject to their being found medically fit in the Pre-Employment Medical Examination to be conducted as per Norms & Standards of Medical Fitness.
- g. Request for change of category (GENERAL/SC/ST/OBC-NCL) once declared in the application will not be entertained.
- h. In the event any applicant has litigated with his employer in the past, the same should be clearly mentioned in the application in brief.
- i. Applications that are incomplete, not in the prescribed format, without the required enclosures, will be summarily rejected without assigning any reasons and no correspondence in this regard will be entertained. Application received after the last date of submission will not be considered.
- j. Candidates employed in Central / State Government department, Central / State PSUs or Semi-Government Organization must produce No Objection Certificate (NOC) at the time of Interview. In case, the candidate fails to produce NOC from his / her present employer at the time of Interview, his / her candidature will not be entertained.
