Probable applicants who have not registered in the one-time-registration portal must register well in advance before the last date of submission of application to enable them to submit their application one time.

An applicant must verify that his/her application is actually submitted after payment is made, otherwise the claim of any applicant regarding his/her candidature will not be entertained.

2. **Name of Post** : *Upper Divisional Clerk*
3. **Classification** : *Group 'B' (Non-Gazetted)*
4. **No. of Posts** : *18 (Eighteen)*
5. **Pay** : *Level 6 in the Pay Matrix*
6. **Relevant Rules** : *1) Mizoram Ministerial Service Rules, 2011*  
*2) Mizoram Ministerial Service Rules, 2021*
7. **Conditions of Eligibility** : *As per MMS Rules, 2011* : From officers holding posts in LDC grade with 5 years regular service in the grade.

*As per MMS Rules, 2021* : From officers holding posts in LDC grade with 7 years of regular service in the grade rendered after appointment thereto on a regular basis.

*Note: The qualifying/eligibility service shall continue to be 5 years for Limited Departmental Examination for persons holding posts in the LDC grade on regular basis on the date of notification of the extant rules as notified in the Mizoram Gazette extraordinary Issue No. 577 Vide No. A.12018/31/2020-PAR(GSW) dt. 30.11.2021.*

8. **Last Date of Application :** 24.07.2026 till 4:00 PM

10. **Essential documents to be uploaded :**

To support their application, the candidates must upload the following documents in the online portal before the last day of application; failure of the same will result in disqualification of the candidate. Any application for alteration of documents already uploaded by the candidate in the online portal should be made positively before the expiry of the last date of application. Any alteration of documents made in the portal after the last date for submission of application shall not be considered for qualification in respect of the particular post applied for.

Documents to be uploaded are:-

- (a) Service Book Entry showing date of joining the feeder post.
- (b) Service book entry showing date of birth.
- (c) Confirmation Order.
- (d) Certification by HoD or Cadre Authority in the format prescribed by the Commission.

11. **Disqualifications :**

- (i) Particulars/Details to be mentioned in the application should be completely and correctly stated. Any application not specifying the required information or incomplete documents of a concerned candidate shall be liable to be rejected.
- (ii) Any candidate who, on verification at any stage of the recruitment process, has been found not to have fulfilled any of the eligibility conditions will be disqualified.
- (iii) Canvassing (**Insawipui**) by a candidate directly or indirectly will disqualify his/her candidature.

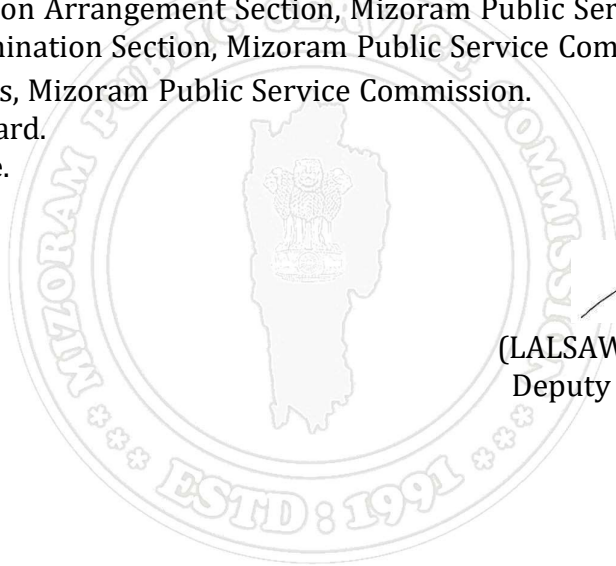
