3.4. Qualification. Ex-servicemen India Domicile (Pension holder only) of Ex-Women employees (including premature retirees) of MoEF & CC & State Forest Department should have rendered minimum service of 20 years in MoEF & CC and State Forest Department.

3.5. Should not be involved in any civil/police cases.

Individual will be paid for embodied period only. Ex-Servicemen, initially be engaged for a period of two years to be extended by one year at a time subject to satisfactory performance.
- 6.2. Enrolment is purely on merit basis and depending upon the vacancies available.
- 6.3. As per Government of India, Ministry of Defence letter No. PC to MF 68640/ECO/Gen/ TA-2/513/US/D(GS-III)/2018 dated 30 Oct 2018, service rendered in Inf Bn (TA) Ecological by ESM are not admissible to pension, increment & gratuity.
- 6.4. Service of Ex-Servicemen & Ex- women employees (including premature retiree) of MoEF & CC & State Forest Department in Infantry Battalions (TA) Ecological units will be treated as rehabilitation & not be treated at par with soldiers in the Regular Army/ Territorial Army.
- 6.5. The authorities conducting the rally will not be responsible for any accident/ injury to the candidates during recruitment rally.
